FULL PLAYING MEMBERS

Full Playing members have the right to a voice and a vote at a General Meeting or Special General Meeting of the Club All playing members will be governed by the rules laid down by the PNG Golf Association and the Royal and Ancient.

FAMILY MEMBERS

Husband, wife (including defacto relationships) and children betweefix and Twenty Three years of age, valid IDs are required for verification of age. Only one nomination fee is payable. Other fees including PNGGA affiliation fees, Liquor Licence fees, locker fees, playing fees etc shall be payable at the appropriate full rate per person. All members of the Family Membership over the age of wenty Three years will be considered to have the same rights of Full Playing Members

MIDWEEK MEMBERS

Midweek members forfeit the right to play on the course or Saturdays, Sundays and Public Holidays. Should they wish to play on these days, they will be subject to rules governing visitors on the courseNo midweek members shall have the right to be present or vote at any General Meeting of the Club

LIFESTYLE MEMBERS

Lifestyle members are limited to 16 rounds of golf per calendar year and can be used 7 days a weekLifestyle members cannot be present or vote in any General or Special General Meeting of the Club. Only available to new members

INTERNATIONAL MEMBERS

Overseas members are limited to 10 rounds of golf per calendar year and must spend no more than 120 days in PNG per calendar year, nor have a primary residence in PNG. Overseas members cannot be present or vote in any General or Special General Meeting of the Club.

SOCIAL MEMBERS

Social Members have full access to our Clubhouse facilites butlo not have playing rights and cannot be present or vote at any General or Special General Meeting of the Club.

ITERMEDIATE MEMBERS

Intermediate members of the Club must be between the ages o£ighteen and Twenty Three and shall have no voting rights nor be elected to the Executive Committee but may be co-opted to assist subcommittees. Junior members are strictly not permitted to consume alcohol in the clubhouse or on

JUNIOR MEMBERS

Junior members of the Club must be under the age of eventeen and shall have no voting rights nor be elected to the Executive Committee but may be coopted to assist subcommittees. Junior members are strictly not permitted to consume alcohol in the clubhouse or on the course.

REFUNDS

Some fees are refundable: (1) Membership refunds are on a quarterly basis and not refundable for the quarter in which the application is received i.e. a member resigning in April receives no refund if a six month member but six months refund if an annual member. Membership refunds are dependent on receipt of a Letter of Resignation from members or the company requesting the refund when membership fees are paid by a company on behalf of an employee.
